

OHR Policy Guideline

Mission Subsistence Allowance (MSA) rates 1 January 2025 – 31 December 2025

OHR/PG/2024/6-24 December 2024

- This Policy Guideline is issued to inform stakeholders of the Mission Subsistence Allowance (MSA) rates applicable from 1 January 2025 until 31 December 2025, in accordance with ST/Al/2021/2.
- It is recalled that mission allowance is a daily allowance payable by the United Nations to cover long-term living costs for accommodation, meals and miscellaneous expenses incurred within a mission are by eligible non-staff personnel during their tour of duty in a field mission, including a peacekeeping operation, special political mission or other field mission.
- 3. In accordance with past practice, in case the MSA rates applicable in a country/location in 2025 is lower than the rate applicable in 2024, the higher rate will be applied to those already in receipt of the higher amount on 31 December 2024 as well as to future recipients who were selected/nominated before 1 January 2025, but only deployed on or after 1 January 2025.
